### Substance:

Our thanks to all those who completed our online sameness questionnaire for Iron, Furnace [Einecs number 265-998-4, CAS number 65996-67-0]. After analysing the results of this survey, we have made some revisions to the "sameness" specification which we believe will satisfy the requirements of all stakeholders. Please click here to see the [revised specification for Iron, Furnace](#) and let us know if you have any objection to this specification - which will otherwise be the basis on which we will proceed towards preparation of the registration dossier for this substance.

Part of the REACH process is to identify the different uses of each substance in order to assess the risk profile of that application. **If your use for Iron, Furnace is other than as feedstock for crude steel production or metal casting, please provide details - if you do not provide this information, we cannot guarantee that your use will be covered in the risk assessment process.**

### Nomination of the Lead Registrant for Iron, Furnace

We believe that it is now the appropriate time to proceed with the election of the Lead Registrant which will take on the responsibility for preparation of the registration dossier, as required by the REACH Regulation.

ArcelorMittal REACH Only Representative has, after due preparation, put itself forward as candidate for Lead Registrant and we recommend that you vote in favour of ArcelorMittal REACH Only Representative as Lead Registrant for Iron, Furnace. The Iron Platform will support ArcelorMittal in the fulfilment of it's obligations as Lead Registrant.

**Please would you therefore confirm your vote in favour of ArcelorMittal REACH Only Representative as Lead Registrant for Iron, Furnace or advise your alternative nomination.**
