DORMANT: This could include companies that have only pre-registered to secure your current business, without the intention for later full REACH registration. Companies that have no wish to be actively involved in the SIEF (beyond their data-sharing obligation) and do not intend to register. Companies that purchase substances and/or preparations and are maintaining the option to import, during the REACH phase-in periods, in order not to diminish your procurement options. Also companies likely to decide that it is sufficient to be a Downstream User and therefore not need to register the substance.

PASSIVE: This could include companies who plan to register, but have limited resources or interest to actively participate in the discussions. Your main interest is participating in the final part of the joint-registration, not participation in the preparation of the technical dossiers.

INVOLVED: This will include companies who want to have some input into the technical dossier creation process, and to register. However, they are not able to make resources available to participate in all the technical meetings and SIEF activities.

VERY ACTIVE: This will include companies for whom the substance is of strategic value to their business, and who can make resources available to actively participate in the technical meetings and SIEF activities.
