### Substance: Mill scale (ferrous metal)

Dear Members of the SIEF for Mill Scale [Einecs number 266-007-8, CAS number 65996-74-9]:

The Lead Registrant is now in the final stages of preparing the registration dossier for mill scale and, all being well, will submit this in a few weeks time. At this point we would like to advise you of the following:

- A guidance document on analysis methods for mill scale will be posted on the Guidance page of the Iron Platform website within this week.

### Classification for Mill Scale

In accordance with Article 29 of the REACH regulation, specifically section 2 (b), the aim of each SIEF shall be to agree classification and labelling where there is a difference in the classification and labelling of the substance between potential registrants.

On behalf of the nominated lead registrant, ArcelorMittal, we hereby propose the following classification for Mill Scale to the SIEF: **no classification**.

If you do not respond within 10 days of the date of this notice the lead registrant will act on the basis of your full agreement to this classification. If you disagree with this classification please respond within 10 days of the date of this notice detailing the specific reasons and scientific data to support your claim.
